GENERAL INFORMATION:

- 2. The Club Information Form is a two sided document, except for the Affiliate Club Form. The second page of the Club Information Form is to be used to list "Co" officers' information and the club contact person information in the event there are any questions.
- 3. **<u>DUES AND CHECK</u>**: The total amount of dues per member is \$20.00 each. (Breakdown is GFWC: \$15.00 per member, CFWC \$4.00 per member and District \$1.00 per member). The club's check for the District is to be made payable to "Orange District".
- 4. The <u>Club Information Form is to be submitted with a check for dues and a **list of members for which the fees are being paid to the District Financial Secretary and is to be received by her no later than May 1.</u>
- 5. The 2020-2022 Remittance Form for New and/or Late Paying Members is to be submitted with a check payable to "Orange District" and a** list of members for which the dues are being paid to the Orange District Financial Secretary and is to be received by the District Financial Secretary no later than the 15th day of each month. Pursuant to Bylaw ARTICLE IV, DUES, Section 4, "No dues will be accepted by Orange District after December 1."
