Today Women's History Month in March is also celebrated in the United Kingdom and Australia to highlight the contributions of women to events in history. International Women's Day is March 8th.

## Margaret (Maggie) Paul Legislation/Public Policy

There are has been some misunderstanding as to what the ERA really says. Below is an article by the GFWC's Women's History and Resource Center Committee Chairman, Hope Royer, which explains the ERA and some history that support the ratification of this amendment.

#### The Equal Rights Amendment: Are we there yet?

The answer is a resounding "no!"

The Equal Rights Amendment (ERA) is not a long amendment made confusing by rhetoric. It is a brief, simply worded, three-section proposal:

**Section 1.** Equality of rights under the law shall not be denied or abridged by the United States or by any State on account of sex.

**Section 2.** Congress shall have the power to enforce, by appropriate legislation, the provisions of this article.

Section 3. This amendment shall take effect two years after the date of ratification.

The ERA was passed by Congress in 1972 and sent to the states for ratification. It was the culmination of a nearly 40-year fight – a fight that appears to be far from over. When the legislation was passed in 1972, it included a seven-year deadline. The ERA failed to achieve the requisite number of state ratifications by the required deadline, so ERA advocates convinced Congress to extend the deadline until 1982. However, the ERA failed, again, in 1982, just three states short of the 38 were needed for ratification. It has been at a stalemate since.

The ERA Coalition and Fund for Women's Equality composed a letter in December 2020, to the incoming administration documenting the urgency of ratification, requesting a pledge from the new administration to encourage publication and certification of the ratification, and removal of the deadline. At the request of the ERA Coalition D.C. Director/ Director of Outreach and Advocacy, and in support of the Coalition's effort, GFWC International President Marian St. Clair added the name of the General Federation of Women's Clubs to the list of organizations that support the ERA.



Thank you to all club members who TOOK ACTION and contacted their House Representative in support of HJ Res 17. It passed the House on March 17, 2021.

HJ Res 17 is a bill that removes the time limit on the ratification of the Equal Rights Amendment.

There is more work to do.

Urge Members of Congress to cosponsor bipartisan House Joint Resolution 17 and Senate Joint Resolution 1 to remove the deadline for ratification of the Equal Rights Amendment.

**TAKE ACTION** 



Once again it is time for GFWC clubwomen to urge Congress to reauthorize the Violence Against Women Act (VAWA). The General Federation of Women's Clubs has long supported local domestic violence shelters and rape crisis centers even before the first Violence Against Women Act was passed by Congress in 1994. Today, we continue to support survivors of domestic violence, sexual assault, dating violence, and stalking with our advocacy, time, energy, donations, resources, scholarships, and commitment to education and prevention.

March is Women's History Month and I would like to let you know what the past GFWC Women have done to promote the GFWC in the past. Due to their work we now have Clubs in many Nations and throughout the United States.



Eleanor Roosevelt helped secure GFWC-NC's financial future by supporting the 2020-2022 GFWC-NC President's Special Project, Corporate Champions for Women & Children, Legacy and 1902 funds, special designation funds and scholarships. Founder Jane Cunningham Croly, who was inducted into the National Women's Hall of Fame in Seneca Falls, New York in 1994, to First Lady Eleanor Roosevelt, who recommended GFWC purchase 1734 N. Street NVV to serve as Headquarters in 1922, the Federation has a long legacy of strong women.



Charlotte Emerson Brown was an American woman notable as the creator and first president of the GFWC, a progressive women's movement in America beginning in the 1890s. During her presidency, membership expanded quickly from 50 cultural clubs to several hundred, and grew to representing tens of thousands of women. She was instrumental in the GFWC's formation of statelevel organizations.

Brown was born in Andover, Massachusetts on April 21, 1838, to Reverend Ralph Emerson and Eliza Rockwell. Brown's father was a professor of ecclesiastical history and pastoral theology at Andover Theological Seminary. Brown was an avid reader and student who spoke many languages. She graduated from the Abbot Academy of Andover. She was Vassar's first female president and stud-

ied business in Chicago. Her first clubs were a music club and a French club and her home in Illinois hosted literary, musical and artistic events. Working part time as a teach from 1879-1880 she served as Jan Addams's teacher of the German language. She became president of the Woman's Club of Orange in 1890, she was elected president of the GFWC, an organization which encouraged women to educate themselves and become advocated in their communities. Advocating for; clean milk, street lights, and libraries, as well as, regulations regarding child labor and child and maternal health. Under her leadership the organization grew from initial meeting of delegates of 61 Clubs to 475,000 U.S. women from 2,865 clubs in the mid- 1920s, and was notable for assisting the career development of advocates such as Eleanor Roosevelt. Membership peaked at 830,000 members in 1955. Brown served as the organization's president until 1894.

Charlotte Brown married William Bryant on July 20, 1880, a congregational pastor who served parishes in several states. She died on February 4, 1895 and was buried in Mount Pleasant Cemetery in Newark, New Jersey.



Orange County Public Libraries (OCPL) is celebrating their 100<sup>th</sup> Anniversary! It started out as Orange County Free Library on August 1, 1921, in a rented room in Santa Ana with a staff of 3 people. By the end of that year there were 8 pioneer branches (still existing today) and 4,609 borrowers. Now with 33 branches and nearly a half-million cardholders, OCPL meets the diverse needs of its communities with extensive electronic resources, and programs & services for all ages, including several types of virtual events.



 The GFWC Education and Libraries Challenge Project is to promote STEM (science, technology, engineering, and mathematics) educational activities encouraging cultural diversity. Think about organizing projects to teach students about various cultures and backgrounds. These could be students from, for example, local elementary schools, Boys and Girls Clubs, or Girl Scout troops.

Do you know who the "hidden homeless" are? They may be a single individual or a family. Are they really hiding? No, they are hiding in plain sight! They have lost jobs, homes, and many, their dignity. They are living in cars, vans, RVs, and campers so you won't find them in shelters or on the street. Since the pandemic started, it has doubled as the housing crisis has worsened. Chances are, they are undercounted in a census and so the state receives less money for services for all its citizens. It is estimated that 1 in 500 Americans are homeless, but it could be more if the "hidden homeless" are counted. Vehicle residency is one of the fastest growing forms of homelessness.

Some of these people do have unemployment benefits and can get food stamps, but they also depend on Food Pantries for food. Many families are afraid to go to a shelter as they don't want Family Services to get involved or are afraid their children will be exposed to unpleasant experiences. An uptick to vehicle living is there is less exposure to the coronavirus than in other homeless living in shelters or on the street.

The main problem is that there are few places these people can stay without getting a vehicle towed (which then costs money). A few churches, non-profits, and local governments have created overnight parking lots with portable toilets and showers, but these are few and far between as funding has dwindled. Of note is that California is one of the states that has stepped up to create Safe Parking Programs. Other states seem to be taking the cue.


